- Maintaining and growing mailing list and membership. Successfully completed and ongoing.
- Conducting a Member Survey. Currently underway.

### WITH TAS STUDENT SCHOLARSHIP

Now in its 11th year, our annual scholarship continues to assist a committed, professional young woman to further her tourism/hospitality studies. In 2023 the successful candidate, Upuli Prabhashini Pathirana, was an outstanding applicant, demonstrating her passion, talent and commitment to our interview panel. Upuli has now completed her Certificate III in Hospitality at TasTAFE and started her Diploma on a pathway to Bachelor of Business – Hospitality Management at UTAS.

We gratefully acknowledge the support of Tourism Tasmania in sponsoring this program for the third year in 2022.

#### PARTNERSHIP OPPORTUNITIES

In March, WITH began discussions with the THA to identify partnerships to deliver meaningful and effective leadership training with support and funding through the THA's Women in Leadership program. We saw this as a strategic step in evolving some of our flagship events – in particular the Industry Leaders Breakfast. In June, an agreement was signed for the THA's sponsorship of the Breakfast and we look forward to partnering with them on October 18.

Likewise, we continue to identify opportunities to collaborate with TICT in sponsoring the International Women's Day Lunch – an event we believe provides synergies between our organisations.

We also continue to seek out additional funding opportunities to support women in our industry.

#### TICT BOARD REPRESENTATION

In April, Emily Hopwood was re-elected to the TICT Board, as nominee for WITH Tas in the Associations College (representing member-based industry and sectorial associations active in the tourism industry and visitor economy).

This is the third term of WITH representation on the TICT Board and Emily's reappointment is confirmation of the important role WITH Tas plays in representing women across the tourism and hospitality sectors in Tasmania.

Thank you to all TICT members who voted for Emily, recognising her experience, expertise and passion for diversity across our industry. Congratulations Emily and thank you for your support of WITH Tas - we look forward to working with you through the remainder of your two-year term.

# **COMMUNITY ENGAGEMENT**

In March, WITH added to funds raised from our raffle enabling a donation of \$3,000 to Small Steps, a live-in support program for young mums and their babies, established by the Hobart City Mission. The funds were used to purchase much-needed large capacity dryers, easing one aspect of a busy young mother's life.

WITH intends to continue this vital support in the coming year with a raffle to be announced shortly.

#### IN CONCLUSION

WITH Tas continues to evolve. Our reach and relationships with other key Tasmanian tourism industry bodies continues to grow as we seek to further establish ourselves as a valuable and respected non-profit industry organisation.

At the conclusion of the 2022-2023 financial year FY we have 1,474 Facebook followers, 478 LinkedIn connections and 442 contacts on statewide mailing list. We also continue building our membership at corporate and individual levels.

The 2022-2023 Committee (see cover) represents an impressive cross-section of the tourism and hospitality sector and I thank them for their hard work and support over the last twelve months. We have met monthly, alternately via Zoom and in person at Hadley's Orient Hotel, who we thank for providing the Gallery space for us.

Finally, a HUGE thank you to all our members, industry partners, prize donors, and the wider community and supporters – without your ongoing backing, so much of what WITH does would not be achieved.
