# President's Report 2023-2024

In presenting this report and reflecting on the activities of Women In Tourism and Hospitality Tas (WITH) over the past year, I am proud of the achievements of our dedicated voluntary Committee in delivering activities that connect, support and inspire women working in our Tasmanian industry. Some highlights are as follows:

#### **WITH EVENTS**

#### September 2023: AGM and 14th Birthday Celebration, Ball & Chain Restaurant.

The AGM saw the retirement from Committee of Jill Bannon after serving WITH for 14 years, including as a founding committee member and president for the past five years. Robyn Moore, of Power of the Word, also an inaugural member of WITH, provided a fitting tribute to celebrate Jill's significant contribution to our association.

General Committee members Aletta Macdonald and Jenifa Dwyer also retired with the positions becoming casual vacancies subsequently filled by Natalie Ellis and Sherene Somerville at the October 2023 Committee Meeting.

#### October 2023: Industry Leaders Breakfast, Henry Jones Art Hotel.

WITH's flagship event was once again an outstanding success with 105 people attending. Guest panelists Analiese Gregory (chef and food innovator), Kitana Mansell (palawa kipli), and Sheralee Davis (CEO Wine Tasmania) were guided in conversation by Sarah Clark (CEO Tourism Tasmania) and all generously shared insights from their career journeys. The support of the Tasmanian Hospitality Association's Women In Leadership program is gratefully acknowledged in contributing to the event's success.

#### December 2023: Christmas Celebration & Scholarship Presentation, Hamlet Café.

Our end-of-year celebration at Hamlet provided an opportunity to highlight the wonderful work of this social enterprise which provides training and employment opportunities for socially disadvantaged people. It was well-attended and enjoyed by all in the festive spirit.

The 2023 WITH Student Scholarship prize was also presented to Upuli Pathirana, studying the Advanced Diploma in Tourism & Hospitality Management at Drysdale TasTAFE. Upuli went on to serve for the year as the Student Member on the WITH Tas Committee and, while now stepping down, Upuli's contribution to Committee has been appreciated.

#### March, June and August 2024: 'Connecting' events.

This year WITH successfully applied for funding under the Tasmanian Government's International Women's Day Small Grants Program 2024. This enabled us to partner with the Migrant Resource Centre (MRC) to host a networking dinner event in March, bringing clients of the MRC together with members of WITH and industry guests including from the Tasmanian Hospitality Association, Tourism Industry Council Tasmania, Destination Southern Tasmania and the Tasmanian Business Advice Service. Information was shared on training and employment pathways in the industry as well as small business support services available. New connections were made and continued well after the event.

In June WITH hosted another Connections @ Drysdale, a lunchtime event for informal engagement amongst members and guests, while supporting the next generation of hospitality professionals in training at Drysdale TasTAFE.

In late June and late August WITH hosted casual get-togethers at the Alabama Hotel and Hadley's Hotel, where members met and discussed shared interests in an informal setting.

#### September 2024: Government House Reception marking WITH's 15th anniversary.

While outside of the reporting period, in August arrangements were being made for a very special celebration. In recognition of WITH's endeavours and longevity as a not-for-profit peer support association for women in our industry, we were honoured in September to be hosted at a Government House reception. Over 80 WITH members and supporters were present including founding president, Sally Deane, who travelled from Queensland to attend.

#### **COMMUNITY ENGAGEMENT**

For a third year, WITH continued its support of Small Steps, a life-changing live-in parenting program for young mums and their babies.

Our thanks to generous raffle prize donors, including On Board Expeditions & Above and Beyond Seaplanes, who helped raise over \$2,000 to enable fresh air for four units - screen doors to let fresh air in and keep the bugs out!

The WITH Committee then added a further \$670 to fund a total of six doors which were very much appreciated.

#### **LOOKING TO THE FUTURE**

The WITH Committee met in early February to plan the year's calendar of activities and explore strategic opportunities.



A fresh look for WITH. This initiated work that has been ongoing throughout the year, including a refresh of the WITH brand and logo and accompanying update of the WITH website. We are excited to report this is almost complete and will be revealed at the WITH end-of-year celebration. Huge thanks to Alice van der Woude and Dani Ruiz who have led this work for their consideration, time and effort contributed to this significant project.

**Next gen support.** Another priority was continuing WITH's support of the next generation of tourism and hospitality professionals through the annual WITH Student Scholarship. In March/April several talented applicants were interviewed by our panel and ultimately two prizes were awarded: the 2024 Student Scholarship recipient is Ardelia Hadiwidjaja of Frontier Education, and the Encouragement Award recipient is Lakmi Hansika of Drysdale TasTAFE, who will receive their prizes at our end of the year function.

Thank you to Tourism Tasmania for its continued sponsorship of the Student Scholarship prize which has enabled the Committee to award a second prize.

**Transition management.** Changes to the WITH Constitution last year formalised the introduction of two-year terms by split rotation of the management committee with half of positions open for appointment each year. This will assist with continuity of business operations and retention of expertise, by ensuring a combination of experienced Committee Members supporting newly appointed members. The Student Committee member position remains as a one-year term.

# Treasurer's Notes 2022-2023

WITH's commitment to transparency and good governance, as well as ensuring preparedness for possible funding opportunities, has again resulted in a professional audit of our annual accounts. Of note:

- Memberships received for 2023-2024 and 2024-2025 (in advance) are combined in Income & Expenses Report.
- Event expenses higher than last year due to 2024 Industry Leaders Breakfast being a larger event that previous. Event expenses vs income disparity due to THA's Breakfast partnership funds received previous financial year.
- Advertising & promotion higher due to WITH re-branding.
- An additional \$670 was added to \$2,000 raffle funds to fund two additional screen doors for Small Steps.

This is my last year on the WITH Tas Committee and I consider myself extremely lucky to have met and worked with an amazing group of women over the last eight years. I'm looking forward to seeing WITH Tas continue to evolve and flourish. You'll also still see me attending events South and North as a WITH member!
